

## **All you need to know about your documents for polling**

The Commission has directed that in the current General Election to the Nagaland Legislative Assembly, 2018 all electors, who have been issued EPIC have to produce the EPIC for their identification at the polling station before casting their votes. Those electors who are not able to produce the EPIC shall produce one of the alternative photo identity documents for establishing their identity.

1. Passport;
2. Driving License;
3. Service Identity Cards with photograph issue to employees by Central/ State Govt. PSUs/ Public Limited Companies;
4. Passbooks with photograph issued by Bank/ Post Office;
5. PAN Card;
6. Smart Card issued by RGI under NPR;
7. MNREGA Job Card;
8. Health Insurance Smart Card issued under the scheme of Ministry of Labour;
9. Pension document with photograph;
10. Authenticated Photo Voter Slip issued by the election machinery;
11. Official Identity Cards issued to MPs/ MLAs/ MLCs; and
12. Aadhaar Card.

As such, authenticated Photo Voter Slip is just one of the 12 documents in addition to EPIC for establishing identity of an electors at the time of voting.

### **CEO NAGALAND INFORMS ON POLL CAMPAIGNING**

CEO Nagaland ,Abhijit Sinha in a press release has informed to all concerned that as per Section 126 of the Representation of the People Act, 1951, the campaigning period for election to the 13<sup>th</sup> Nagaland Legislative Assembly, 2018 shall come to an end w.e.f. 4:00 PM – 25/02/2018. In this regard ,the District Election Administration / Police Administration are directed to ensure that all political functionaries shall leave the constituency immediately after the campaign period is over. However, the said restriction may not be insisted upon the office bearer of the political party who is in-charge of the State. Such office bearer of the political party shall declare his place of stay in the State Headquarters and his movement during the period in question shall remain confined normally between his party office and place of his stay.
